3. Age permitting, couples are restricted to dance in one of Adult, Masters I or Masters II events.
4. Note that there are combined events for Level 1 Masters I and Masters II competitors.
5. Youth competitors may also dance in the Adult events subject to age eligibility.
6. Juvenile & Junior couples may dance up one Level (in accordance with the syllabus of events).
7. Junior Open events are restricted to Level 2 and above.
8. Sub-Juvenile competitors may also dance in the Juvenile events.
